Subject annotation in English

The aim of the course is to analyze the dynamics of national, regional and co-European identity, and that of the processes of general social and cultural transformation in the Baltic countries after disintegration of the Soviet Union. Students will be provided with modern literature in the field of the study of the Baltic region. Since literature is relevant to political science, intellectual history, social anthropology, and sociology, some of interesting interdisciplinary approaches to liberal arts and social sciences will be used.
