Results to be achieved: students will be able to understand the processes of social-economic development in different countries, to interpret economic phenomenon, economic institutions and actors using the conceptions of markets, culture, embeddedness, social networks, entrepreneurship, etc. Teaching methods used in the course: theoretical lectures, seminars and in-class discussions, team-based presentations, course paper.

Prerequisites for entering the course

Students are required to complete the subjects "Classical and Modern Sociological Theories", be fluent in English and use Internet resources.

Course aim

The aim is to develop students' skills to identify the problems of modern economic sociology, apply the conceptions and theoretical approaches of economic sociology for the analysis of diverse social-economic processes; apply the conceptions of post-liberalism, modern capitalism and transformational state for the analysis of socio-economic development in different countries and provide solutions for solving problems.
