## **Subject annotation in English**

Baltic countries in the 13th-16th centuries: the emergence of German and Slavic influences. Political and cultural development in the Baltic countries in the 16<sup>th</sup>-18<sup>th</sup> centuries. Lithuania in the Republic of Two Nations in the 16th-18th centuries: cultural and political changes. Polish-Lithuanian state on the crossroads between Russia and Westem Europe. Russian occupation in the Baltic countries: cultural and political changes. National rebirth in Lithuania, Latvia and Estonia.

Form of studies- discussions, presentations, work in groups, individual work, seminars.

The aim of the course is to overview the most important historical developments, periods and tendencies in the Baltic countries in the 16th-19th centuries. To analyse Russian and Western European influences on the Baltic countries and raise students awareness of the historical literature to analyse the development of the Baltic region in the European context.

After completing the course students will be able:

- Understand the historical importance of the Baltic region to European development.
- Evaluate and compare the complexity of the various ethnic groups of the region and be able to differentiate between these.
- Analyse how changing attitudes both in the North Western peripheries and in the imperial metropolis influenced the process of nation-making.
- Develop a better understanding of the relationship between ideology, policy and social processes in the Baltic societies and Eastern Europe.
- Analyse the various theories of historical development and be able to apply the concepts of state and society, the collective and the individual, ethnicity, gender and identity.
- Think critically and imaginatively about the subject matter.
- Identify and address key problems in the history of the Baltic region including the extent to which it was affected by modern ideologies, social change, revolution, warfare and displacement.
- Analyse the political, social, economic and cultural heritage of the Baltics with a view to understanding the particular nature of systemic change and development, demonstrate the comparative skills necessary for cross cultural analysis.
- Construct coherent and independent historical arguments of their own.
