Course title in English

Ethnicity and Nationalism

Short course annotation in Lithuanian (up to 500 characters)

Kurse pristatomos etniškumo ir nacionalizmo antropologinės definicijos. *Etniškumo ir nacionalizmo* sampratos analizuojamos per transnacionalizmo bei multikultūriškumo procesus globaliame pasaulyje, o taip pat per etninių/nacionalinių diskursų ir naratyvų raišką pačiose nacionalinėse valstybėse. Aptariama etninės bei nacionalumo politikos sampratos ir pavyzdžiai, etnonacionalizmas, nacionalinio identiteto politika ir pan.

Akcentuojami įvairūs lokaliniai bei regioniniai etniškumo ir nacionalumo ypatumai, taip pat globalizacijos daroma įtaka etninių ir nacionalinių identitetų transformacijoms. Šiuolaikinė migracija, valstybės ir nacijos deteritorializacija yra pateikiamos kaip pagrindinės probleminės ašys, padedančios pabrėžti šiuolaikinių etninių ir nacionalinių procesų ir saitų įvairiakryptiškumą, kompleksiškumą ir ryšio tarp deteritorizuotų tautų ir tautinių valstybių palaikymą.

Etniškumas matomas kaip vienas iš ryškiausių globalizacijos antipodo-fragmentacijos pavyzdžių. Nacionalizmas matomas kaip vienas iš svarbių šiuolaikinę visuomenę veikiančių veiksnių, kaip dominuojantis diskursas etninių ir rasinių mažumų atžvilgiu bei kaip mobilizuojantis veiksnys santykyje su multikultūralizmo politikomis ir transnacionalizmo bei migracijos procesais.

Short course annotation in English (up to 500 characters)

The course focuses on the contemporary anthropological approaches to ethnicity and nationalism. Ethnicity and nationalism is defined and analyzed through the processes of transnationalism and multiculturalism. Referring on the data from diverse settings of the world particular local and regional patterns of ethnicity and nationalism as well as the impact of globalization on their transformation is taken into account. Contemporary world population mobility flows are presented as a factor which influences the process of de-territorialisation as a recent challenge to the nation and to the state.

Ethnicity and nationalism are seen as a link of de-territorialized nations and ethnicities with their nation-states and/or homelands. Ethnic and national identities are analyzed vis-à-vis identity enactment in different nation-state, ethno-nationalist, diasporic etc. settings and in relation to the state politics of 'melting pot', multiculturalism etc. Particular focus is on the patterns of ethnicity- nationalism used for ethnic-nationalism and for identity politics

The need and relevance of the subject

The need and relevance of the critical conceptualization, discussion and application of 'ethnicity' and 'nationalism' categories and possibility of their usage for the analysis of contemporary global processes of de-territorialization, homogenization and fragmentation as vectors working for consolidation and/or segregation of particular groups, communities and societies.

Course aim

To cover the analytical scope of different categorizations of 'ethnicity' and 'nationalism' for to learn to navigate through this diversity by recognizing particular narratives, discourses, identities, strategies and policies which unite or divide people in the same society and in different societies.

Study course content, topics and study methods

- 1. Theoretical perspectives in anthropology and sociology used to define phenomenon of ethnicity and nationalism.
- 2. Conceptualization of "ethnicity": from primordial to constructivist perspectives.
- 3. Ethnic and national identities. Ethnicity and nationalism politics vis-à-vis ethnic-cultural group and minority politics.
- 4. Ethnic and national culture embeddedness: representations of 'traditions', 'heritage', 'past' and politics of multiculturalism.
- 5. Ethnic nationalism: dichotomy of the 'ethnic' and 'civic' nations and their enactment in different settings.
- 6. Globalization and de-territorialization of the nation and nation-state: processes of entification, indigenization, regionalism etc.
- 7. Transnationalism, migration and nationalism: diasporic-homeland nationalism, cultural citizenship and politics of ethnic identity.

Migration and Politics of Identity

Short course annotation in Lithuanian (up to 500 characters)

Šiame kurse iš antropologijos perspektyvos nagrinėjama globalaus mobilumo, deteritorializacijos ir transnacionalinės migracijos procesų sociokultūrinė raiška. Short course annotation in English (up to 500 characters)

This course focuses on trans-local dimensions of global mobility and transmigration in terms of identity politics. The emphasis is on lived experiences of the patterns of transnationalism across different sociocultural settings.

PhD students will learn how contemporary anthropological approaches on politics of identity in global contexts can provide new ways of understanding of the emergence of the new transnational spaces. Students will learn how to apply a comparative perspective for exploring transnationalism, (im)mobility, loyalty and belonging from lived experiences of transnational migration in Europe, North America, South Asia, and also how to identify problematic situations related to identity (dis)empowerment.

The need and relevance of the subject

The need and relevance of the course is that it provides with the understanding of contemporary phenomenon of mobility, immobility and migration from the grass root level perspective and enables PhD students to apply identity paradigm by focusing on its strategic and political sides of empowerment.

Course aim

To learn to navigate through diverse settings of global migration by using bottom-up perspective on to understanding of this phenomenon by enhancing the application of identity politics and identity strategies as analytical tools for it.

Study course content, topics and study methods

- 1. Theories of globalization, de-territorialization, global mobility and (im)mobility, fragmentation, and localness
- 2. Conceptualization of transnationalism and national identity politics from anthropological perspective.
- 3. Migrant identities: strategies and practices.
- 4. Identity politics: resources, models. 'dominant' and 'demotic' configurations of it (Gerd Bauman).
- 5. Empirical models of identity politics: 'diasporic-homeland nationalism' (Glick-Schiller) 'cosmopolitism with roots' (Hollinger), 'hyphenated identity' etc.
- 6. Return migration and moral economy: social remittances and meritocracy.
- 7. Forced migration: 'imperial debris' (Stoler) and forced displacement: patterns from Eastern Europe.
- 8. Analysis of migrant identity cases from Europe, North America, and South Asia.

Sociology of Culture

Short course annotation in Lithuanian (up to 500 characters)

Kurse pristatomos skirtingos šiuolaikinės kultūros sociologijos teorinės perspektyvos, metodologinės problemos ir empiriniai tyrimai. Aptariamos tokios temos kaip kultūrinės industrijos ir kultūrinės rinkos, kultūrinių objektų ir auditorijų santykis, subkultūrų konstravimas, kultūros ir emocijų ryšys, terapinės kultūros įsigalėjimas, postmodernios kultūros plėtotė ir kultūros studijos (*cultural studies*), prekariteto, seksualumo, sėkmės ir nesėkmės kaip kultūrinių objektų konstravimas. Kurse gilinamasi į kultūros sociologijos studijas apie kultūros gamybą, platinimą ir vartojimą. Daug dėmesio skiriama populiariajai kultūrai.

Short course annotation in English (up to 500 characters)

This course focuses on current theoretical perspectives, methodological issues, and empirical work in the sociological study of culture. It examines selected topics in the sociology of culture and different perspectives of the study of culture. Sociological accounts of the production, distribution and consumption of culture and different modes of analysis of culture and cultural products are also studied during the course. The course covers such topics as cultural industries and markets, the relationship between cultural objects and audiences, the construction of subcultures, the relationship between culture and emotions, the construction of social problems, organizational cultures and subcultures, urban culture, postmodern culture and cultural studies.

The need and relevance of the subject

The course helps to orientate oneself within the framework of contemporary trends in the sociology of culture and to apply theories from the sociology of culture and cultural studies to the analysis of specific cultural objects.

Course aim

- to discuss different theoretical and methodological perspectives in contemporary cultural sociology;
- to analyze the research problems related to the production, distribution and consumption of culture by applying different theories of contemporary cultural sociology;
- to analyze the relationship between cultural objects and audiences:
- to discuss the problems of high, low and popular cultures in the context of contemporary cultural theories;
- to discuss the social problems constructed in different cultures using the contemporary theories of cultural sociology analyzed in the course;
- to analyze the main trends in cultural studies and contemporary subculture research.

Study course content, topics and study methods

- Topic 1. Culture and the contemporary sociology of culture. Cultural objects and culture as social creation. This topic analyzes the relationship between society and culture, cultural innovation, and the relationship between subcultures and culture at large.
- Topic 2. The production, distribution and consumption of culture. The field of cultural production. Art and artists. Cultural production in the sociology of Pierre Bourdieu.
- Topic 3. Culture, the sociology of culture and emotions. The rise of therapeutic culture. Therapy as a new emotional style in contemporary cultures.
- Topic 4. Culture, the body as cultural capital and class. The relationship between cultural capital, habitus and the body is analyzed by using Bourdieu's sociology and B. Skeggs's cultural studies.
- Topic 5. The cultural construction of success and failure. Analysis of popular culture and Oprah Winfrey.
- Topic 6. The cultural construction of social problems. Precarity as a social problem. Precarity and culture/art.
- Topic 7. Culture and sexuality. The organization of sexuality in different subcultures and mainstream culture. A counter-sexual society?
- Topic 8. Another look at affects and emotions in culture. Cruel optimism and culture. Aesthetic/artistic reactions to cruel optimism.

Study methods - lectures, seminars, tutorials, independent work.

Evaluation criteria of study achievements

Students are able to discuss the theoretical and methodological perspectives of contemporary cultural sociology;

- Students are able to analyze research problems related to the production, distribution and consumption of culture, applying different theories of contemporary cultural sociology;

Course title in English

Theories of Gender Studies

Short course annotation in Lithuanian (up to 500 characters)

Kurse analizuojamos svarbiausios istorinės ir šiuolaikinės lyčių studijų bei lyčių sociologijos problemos ir gilinamasi į moterų, lyčių bei vyriškumo studijas. Kurso metu pateikiamos teorinės ir empirinės lyčių ir hegemoninių struktūrų, tokių kaip tauta, rasė, etniškumas, klasė, analizės. Poststruktūralistinių teorijų požiūriu apžvelgiamos lyties, kūno, seksualumo, intersekso, tarplytiškumo ir multilytiškumo sąvokos. Aptariamos tradicinių ir alternatyvių vyriškumo ir moteriškumo formų teorinės analizės bei lyčių tapatybių kultūrinis konstravimas.

Short course annotation in English (up to 500 characters)

This course focuses on contemporary gender studies, men's studies and sociology of gender. It discusses issues related to theoretical and empirical gender studies with the emphasis on postmodern and poststructuralist gender perspectives. Hegemonic structures including nation, race, ethnicity, class etc. are examined. The course analyzes the notions of transgender, transexual, intersex and multisex relating them to the issues of livable life, grief and humanness.

The need and relevance of the subject

The course focuses on the most relevant perspectives of gender studies and gender theories in relation to the social problems of the contemporary world.

Course aim

- to assess the influence of post-structuralist and post-modern theories on the contemporary concept of gender;
- to discuss different approaches to gender relations and the conceptual and theoretical tensions that arise from them:
- to analyze the various processes of the social and cultural construction of gender in relation to different institutions, cultures and ideologies;
- to analyze the links between changes in gender relations and broader social and cultural processes and social problems;
- to analyze how contemporary theories of gender conceptualize the relationship between gender and other social factors such as race, ethnicity, class and religious beliefs.

Study course content, topics and study methods

- Topic 1. Gender as practice. This topic introduces the conceptualization of gender as social practice. It discusses the relationship between gender, power and justice. Gender systems, gender roles and practices.
- Topic 2. Gender as norm. This topic discusses the conceptualization of gender norms as actively shaping reality. The regulatory power of gender and disciplinary gender regimes. Gender as an indicator of humanity and non-humanity.
- Topic 3. Gender and liveable life. This topic analyses the relationship between gender and survival and discusses the gender politics that create a liveable life. Why are some subjects assigned a life that cannot be lived?
- Topic 4. Gender and sexuality. This topic discusses the relationship between desire and sex and the different types of sexuality.
- Topic 5. Rural/urban sexuality and gender. This topic analyses the differences between urban and rural sexual representations. Metrosexuality and metronormativity.
- Topic 6. Interactions between gender, race, class, age etc. This topic deals with state-sanctioned forms of racism, poverty, homophobia and transphobia.
- Topic 7. Transgender vs. transsexual. This topic discusses the autonomy of transsexual and transgender people and their navigation between norms. Gender performativity vs. gender performance.
- Topic 8. The transgender body. This topic discusses the subcultural bodies of transgender people and debates their utopian possibilities.
- Topic 9. Travesti. This topic deals with the specific case of the Brazilian Travesti. Non-normative configurations

of gender and sexuality.

Topic 10. Queer time and postmodern geography. This topic analyses the relationship between queer space and embodied gender practices and discusses queer counterpublics or oppositional cultures. Geographies of Resistance.

Topic 11. Men's Studies. This topic discusses the social and cultural studies of men and masculinity.

Topic 12. Masculinity, social change and conflict in global society. This topic discusses the state of contemporary men's studies, gender and sexuality studies, and outlines future perspectives.

Study methods - lectures, seminars, consultations, independent work.

Evaluation criteria of study achievements

- Students are able to critically analyze the influence of post-structuralist and post-modern theories on the contemporary concept of gender;
- Students are able to discuss different approaches to gender relations and the conceptual and theoretical tensions that arise from them:
- Students are able to analyze the various processes of social and cultural construction of gender in relation to different institutions, cultures and ideologies;
- Students are able to analyze how changes in gender relations are linked to broader social and cultural change processes and social problems;
- Students are able to analyze how contemporary gender theories conceptualize the relationship between gender and other social factors such as race, ethnicity, class and religious beliefs.
- Students write an essay analysis of a selected reading or two readings.
- Students submit a final essay/article on a chosen topic in gender studies.

Course title in English

Migration and social change

Short course annotation in Lithuanian (up to 500 characters)

Kursas skirtas gyventojų migracijos, kaip integralios geografinių, demografinių ir socialinių procesų sudedamosios, analizei. Dėmesys skiriamas migracijos terminologijai, tyrimo metodologijai, informacijos šaltiniams. Analizuojama: gyventojų migracijos tipai ir formos, migracijos raida istorinėje plotmėje ir šių dienų iššūkiai pasaulyje, ES ir Lietuvoje; migracijos priežastys (stūmos ir traukos veiksniai) ir pasekmės; su migracijos susiję reiškiniai ir procesai – multikultūriškumas, tolerancija, etninės problemos, integracija. Ypatingas dėmesys skiriamas gyventojų migracijos teoriniam diskursui/ migracijos teorijoms: analizuojamos ekonominė, sociologinė, transnacionalizmo prieigos. Migracijos politikos formavimo principai ir instrumentai bei šių dienų migracijos politikos aktualijos ES ir Lietuvoje. Aptariamos svarbiausios migracijų tendencijos Lietuvoje ir jų pasėkmės Lietuvos regionų raidai. Pristatoma migracijos problematikos viešajame diskurse ir žiniasklaidoje problema.

Short course annotation in English (up to 500 characters)

The course is dedicated to the analysis of population migration phenomenon as an integral part of spatial, demographic and social economic processes. Attention is paid to terminology, different methods of research, reliability of information sources. Analysis is on: types and forms of migration, migration development in historical perspective and current challenges worldwide, in EU and Lithuania; sources ("pull" and "push" factors) and consequences of migration; topics related to migration – multiculturalism, tolerance, ethnic problems, integration. Special attention is paid to theoretical discourse and different approaches in migration theories: economic, sociological, and transnational. Fundamentals of migration policy formation as well as nowadays political topical issues in EU and Lithuania. The most recent trends of migration in Lithuania and its consequences on regional development is discussed. Migration issues in public discourse and mass media are analysed.

The need and relevance of the subject

European integration and growing globalisation in general fosters emigrational processes around the World, Europe, Baltic Sea region and inside the Lithuania as well. These processes influence all aspects of societies in all countries. Growing military conflicts, economic recessions, natural disasters or gradual climate change increase the number of refugees, economic migrants and facilitates migration in general. The control of these flows is difficult and causes conflicts itself. The problem of integration of migrants is topical in all western countries and Lithuania encounters it more and more. The understanding of factors of migration and its consequences is of high importance from scientific point of view for most social studies. Migration is inevitable and long-lasting phenomenon but is social and economic consequences are extremely different under different circumstances. The migration in Lithuania is a major factor of development since the end of 19th century and at present its the main factor changing geodemographic picture of the country, defining main trends of development of its cities and regions.

Course aim

Full understanding of migration processes and ability to analyse contemporary migrations, politics and related problems at local, regional, international and global scale Deep understanding of theoretical approaches of migration studies and ability to apply them researching these processes and policies governing them.

Study course content, topics and study methods

The course is subdivided into these main topics.

- 1. Theoretical foundations and concepts of migration. The problem of the practical application of theories.
- 2. Use of sources of information on population migration and various research methods; assessment of their reliability.
- 3. Migration policy. Current issues of migration policy in the world, the EU and Lithuania. What is regulated by EU law, what is left to national law?
- 4. Migration as a factor in spatial inequality: migration's new economic theory (SSA) The new economics of labour migration), Dual labour market theory, Migrant network theory and the theory of world systems.
- 5. Economic migration: theoretical discourse, situation, challenges, labour migration, labour mobility; brain drain and migration for study purposes.
- 6. Illegal migration and trafficking in human beings: situation, problems, politics in Lithuania and the EU.
- 7. Migration and ethnic problems, integration of migrants. Challenges of theoretical access to the integration of migrants, their practical realization. Refugees and asylum seekers in the EU and Lithuania
- 8. Migration and territorial identity. "Deteritorization" of identity. A sense of place and stories of migrations. Humanistic and biographical approaches in the theory of migrations.
- 9. Migration issues in public discourse in Lithuania, attitudes towards immigrants. Myths and the reality about the influence of migrants on the economies and social systems of the countries of origin and destination.
- 10. Domestic and international migration in Lithuania: trends, influence on the change in the number and composition of the population in the country and its regions.
- 11. Migration and gender, migration and family. How gender shapes the experience and direction of migration; how family ties are preserved through the distance (ties between the migrants and the rest of the family members).

The course is based on self-studies of references sources and preparation of written project work on the topic agreed with the course teacher.

ETHNIC POLICY AND IDENTITY CONSTRUCTION IN THE SOVIET UNION

Short course annotation in Lithuanian (up to 500 characters)

Kursas skirtas Sovietų Sąjungos įgyvendintos 1917–1991 m. etninės politikos analizei. Daug dėmesio sutelkta į šios politikos ideologinį turinį ir įgyvendinimo ankstyvuoju bei vėlyvuoju sovietmečiu aspektus, rusų vaidmens Sovietų Sąjungos etninės politikos ir ideologijos turinyje aptarimui, etninių grupių hierarchijos konstravimui gyventojų surašymuose, etniškumo ir istorijos politikos santykiui, etninės politikos įgyvendinimo Baltijos respublikose ypatumams.

Short course annotation in English (up to 500 characters)

The course is devoted to the analysis of the ethnic policies implemented by the Soviet Union in 1917–1991. The main attention is focused on the ideological content of this policy and various aspects of its implementation in the early and late Soviet era. The course also covers such issues as the role of the Russian ethnic group in the ethnic policy and ideology of the Soviet Union, the construction of the hierarchy of ethnic groups in public censuses, the relationship between ethnicity and the politics of history, the implementation of the Soviet ethnic policy in the Baltic republics.

The need and relevance of the subject

The subject is needed in order to understand the trends of contemporary ethnic and geopolitical processes, the politics of memory and historical justice in the post-Soviet space.

Course aim

The aim of the course is to introduce to the main stages of implementation of the ethnic policy in the Soviet Union, ideological basis of the policy, theoretical and methodological approaches to the research of ethnicity in the Soviet Union.

Study course content, topics and study methods

- Topic 1. The concept of the national question in the ideology of the Russian Bolshevik Party after October Revolution in 1917.
- Topic 2. Ethnic diversity and state statistics: the construction of ethnic groups in the Soviet censuses of population
- Topic 3. Implementation of the positive discrimination or "Back to roots" policies in the republics of the Soviet Union
- Topic 4. "First among equals": the formation and diffusion of Russocentrist ideology in the period of the late Stalinism
- Topic 5. The formation of a new historical community: internationalism, "friendship between nations" and patriotism in the late Soviet era
- Topic 6. Peculiarities of ethnic policy in the Baltic republics in the period of the Soviet occupation

Short course annotation in Lithuanian (up to 500 characters)

Kursas supažindina su socializmo kaip specifinės politinės ekonominės organizacijos formos ir visuomenių raidos po socializmo žlugimo antropologiniais tyrimais. Aptariamos šiame tyrimų lauke vartojamos pagrindinės sąvokos ir jų problematika, regiono bei laikotarpio apibrėžties iššūkiai, post-socializmo ir po-kolonializmo teorinių prieigų skirtumai, panašumai ir galima sąveika. Kurse svarbus komparatyvistinis aspektas, t.y. aptariama kaip socializmas ir/ar post-socializmas skiriasi įvairiuose kontekstuose (buvusio Rytų bloko šalyse, Kinijoje, kt.). Kurso metu diskutuojamos tokios temos: kasdienis gyvenimas socialistinėse visuomenėse; visuomenė, kultūra, ekonomika socializmo ir post-socializmo laikotarpiu; socialinės kaitos ir stabilumo teorijos; posovietinės nostalgijos ir atminties klausimai, kita. Supažindinama su kritika šiam tyrimų laukui susijusi su "kito" reprezentavimo, Vakarų galios ir kitais klausimais. Kurso dalyviai diskutuoja, ar terminas post-socializmas vis dar vartotinas skirtinguose istoriniuose ir geografiniuose kontekstuose.

Short course annotation in English (up to 500 characters)

The course introduces to ethnographic / anthropological investigations of societies under Socialism and various trajectories of their transformations after its demise. The course overviews and critically discusses the main concepts used in this field, as well as introduces critical discussions on definition of the region and time span referred to as post-socialist / post-Soviet. The interrelation of post-Socialist and post-colonial studies is assessed. The comparative approach is applied by focusing on ethnographies from different regions (former European socialist countries, China, etc). The course includes such themes as everyday life under Socialism, society, culture and economy; social change and stability; post-soviet nostalgia and memories of socialism, etc. The critical reflections are overviewed in this field on representation of the "other" and power relations between "West" and "East". The course participants discuss whether the term post-socialism is still relevant in different geographical and historical contexts.

The need and relevance of the subject

The course introduces into the field of ethnographic/anthropological research in societies under Socialism and afterwards, applies comparative perspective and critical estimation of the field.

Course aim

To introduce the field of ethnographic / anthropological research in the societies under Socialism and post-Socialism as well as reflect on methodological and theoretical tools in these studies and their application

- 1. Socialist state and society: ethnographic studies and theoretical insights.
- 2. Studies of postsocialism and postcolonialism: overlaps and lessons.
- 3. Methodological approaches in anthropology in studying socialism and post-socialism.
- 4. Ethnographies of everyday life in socialism and post-socialism. Culture and economy.
- 5. Identities: gender, class, ethnicity
- 6. Citizenship and civic activity
- 7. Rural and urban transformations. Ethnographies of spaces.
- 8. Religion and socialism. What has been happening after.

- 9. Changing understandings of private and public.
- 10. Social memories and identitites.
- 11. Reflecting on the concepts: socialism, post-socialism, etc.

Sociology and Anthropology of Religion

Short course annotation in Lithuanian (up to 500 characters)

Dalyko metu analizuojamos religijos ir religingumo šiuolaikinėje visuomenėje problemos. Pirmoje kurso dalyje nagrinėjamos šiuolaikinės sociologinės bei antropologinės religijos interpretacijos, jos kaitos bei vietos šiuolaikinėje visuomenėje teorijos bei tyrimų metododologijos. Antroje dalyje nagrinėjamos aktualios religijos šiuolaikinėje visuomenėje problemos – kintančios religinio tapatumo ribos, religingumo ir dvasingumo sankirtos, netikėjimo reiškinys, naujųjų religijų ypatumai, religijos ir valstybės santykiai.

Short course annotation in English (up to 500 characters)

The course analyzes the problems related to religion and religiosity in contemporary society. The first part of the course discusses the sociological and anthropological approaches to religion, discusses the theories explaining the change and place of religion in contemporary society, and overviews recent academic debates and its research methodologies. The second part of the course analyzes the actual problems of religion in contemporary society – the changing boundaries of religious identity, religiosity, and spirituality, the phenomenon of non-belief, new religions, and state and religion relations.

The need and relevance of the subject

After completing the course, students will have sufficient knowledge and skills to analyze and solve the most pressing social problems of the global world. The problems that arise in the confrontation of different religious beliefs and practices and their links with different religious identity politics. The acquired knowledge will allow dealing with these problems competently by analyzing the models of religion, state, and power relations and contextualizing them with sociocultural differences and global and local transformations.

Course aim

The main goal of the course is to explain the place and change processes of religion in modern society by applying sociological and anthropological theoretical perspectives and taking into account different contexts of place and time.

Study course content, topics and study methods

Social and Cultural Identity

Short course annotation in Lithuanian (up to 500 characters)

Kurse gvildenamos socialinių ir kultūrinių identitetų konfigūracijų-modelių konstravimo(osi) ir jų tarpusavio sąveikos peripetijos apčiuopiant institucinio-normatyvinio ir pačių žmonių(grupių) konstruojamo socialinio prisiskyrimo skirtinguose sociokultūriniuose kontekstuose lygmenis.

Akcentuojami identiteto konstravimo resursai, jų pasirinkimo strategijos, o taip pat ir naratyviniai bei diskursyviniai identitetų raiškos aspektai. Socialinio identiteto konstravimo praktikos ir procesai aptariami kaip "skirtingumo" daryba socialinės organizacijos ir socialinės sąveikos rėmuose.

Aptariami identifikaciniai procesai ir juose svarbūs socialinės atminties, kultūrinio paveldo, socialinio kapitalo dimensijos.

Identiteto politikos (iš viršaus) bei identiteto galios (iš apačios) santykis ir sąveika.

Short course annotation in English (up to 500 characters)

The conceptualizing of social and cultural identity is discussed as potential research platform for doctoral students individual research projects. It addresses practices and processes of construction of identity/belonging and alterity/difference making in relation to social organization and social interaction. Concepts of identity as a resource of social belonging are discussed with reference to examples from different sociocultural contexts.

Strategies and politics of identity: 'identity politics' and 'politics of identity' are discussed and exemplified as particular patterns of identity 'from above' and identity 'from below'.

The focus will be on identity models constructed by migrant, national, ethnic and also by socially excluded groups. Lithuanian-ness is taken as case study for understanding identity research based on recent research projects.

The need and relevance of the subject

The need and relevance of the course is to conceptualize and critically discuss the paradigm of social and cultural identity as research perspective and its usage in individual research projects of PhD students. Special attention is paid to the resources of identity construction, strategies of its usage as well as to narrative and discursive ways of its enactment. Also identity politics and politics of identity are discussed as the most urgent issues of identity empowerment.

Course aim

Critical analysis of the paradigm of *social and cultural identity* and ability to employ it for analysis of sociocultural relationships across different settings.

- 1. Conceptualization of social and cultural identity in contemporary anthropology.
- 2. Differences in between social and cultural identity in anthropology and the limitations of usage of identity as a research perspective in anthropology.
- 3. Construction of identity models: institutional-normative and folk models and resources used for construction.

- 4. The practices and processes of identity construction and difference making in relation to social organization and social interaction: resource of social belonging; examples from different sociocultural contexts.
- 5. Primordial identity: indigeneity and autochthony.
- 6. Cases of ethnic, regional, religious identity and their interplay.
- 7. Civic, national, and transnational identity in the globalization process.
- 8. Identity politics and politics of identity (institutionalized and 'demotic' identities J. Hill, T. Wilson, G. Baumann).
- 9. Relationship between identity and power in terms of the nation state and the role of individuals and grassroots movement vis-à-vis nationally produced hegemonic definitions of citizenship.
- 10. Social and cultural identity relationship to issues of mobility and migration, ethnic minorities, and social exclusion.
- 11. Analysis of case studies on identity from different methodological perspectives and in different ethnographic settings (based on the research project data).

Short course annotation in English (up to 500 characters)

The course deals with theoretical, methodological, ethical, and practical issues related to the anthropological research. Students become aware how to apply sociocultural anthropology research paradigms and methods. Specific focus is on conducting fieldwork and ethnography: participant observations, in-depth interviews, life-history interviews, field notes, systematization of materials and writing up of the ethnography.

Students become aware how to prepare fieldwork-based research project with a defined research site(s) as well as practical and ethical considerations of the fieldwork. The ethical aspects of undertaken research are discussed extensively by using American Anthropological Association code of ethics of anthropological research.

The need and relevance of the subject

The need and relevance of the subject is that it enhances application of anthropological approaches and paradigms to be used by embarking on empirical research which prerequires certain amount of anthropological fieldwork. It also embarks on empirical research based on the other qualitative social research methods.

Course aim

To gain experience in application of anthropological analytical perspectives by relaying on comprehension of anthropological approaches based on contemporary theoretical paradigms and on advancement of using the fieldwork and other anthropological methods.

- 1. Introduction and overview of research perspectives in anthropology: holism, cultural relativism, comparativist perspective, constructivism, reflexivity.
- 2. Social research methods and anthropological methodology. Prerogative of empirical research by applying anthropological fieldwork, observation, and participant observation methodology.
- 3. Contemporary understanding of emplacement of anthropological fieldwork: site , multi-sited ethnography, 'new social field'.
- 4. Anthropological understanding of ethnography: classic, modern, postmodern.
- 5. Ethnography as process and as cultural text: conducting ethnography and writing culture.

- 6. Multi-sited ethnography: possible research sites and communities to be identified and critically assessed.
- 7. Participant observation: core method in ethnography and its ethic. Classic principles of conducting participant observation and limitations of these principles.
- 8. Ethnographic field notes, research questions and interview guidelines. Ethnographic authority and writing culture approach.
- 9. Participant observation and in-depth, semi-structured and structured interview. Life history method.
- 10. Narrative analysis, systematization of research materials: coding and indexing.
- 11. Fieldwork based research project preparation: identification of possible research site(s), methods, overview of practical and ethical issues.
- 12. Ethics of the anthropological research: authority of the ethnographer, reflexivity, presentation of data. Responsibility of the ethnographer vis-à-vis interlocuters and their community. 'Anthropology at home' and methodological nationalism.

Short course annotation in Lithuanian (up to 500 characters)

Studijų dalykas aprėpia socialinės politikos analizės teorinius pagrindus ir pagrindines koncepcijas, charakterizuojančias žmogaus socialinę raidą bei socialinės apsaugos principus. Atskleidžiama socialinių rizikų bei socialinių problemų šiuolaikinėje visuomenėje samprata, o taip pat socialinės apsaugos sistemų praktiniai sprendimai ir jų dinamika/raida. Socialinės gerovės problemos aprėpia socialinio teisingumo sampratas, gerovės valstybės istorinę raidą ir jos modelius, globalizacijos iššūkius gerovės valstybei bei jos modernizavimą. Short course annotation in English (up to 500 characters)

The subject aims to overview theoretical perspectives of social policy analyses, social problems and social risks in contemporary society and the main elements of social protection. It also covers concepts of social justice, development of the Welfare State, challenges raised by globalization and modernization of social protection. The subject is specifically oriented towards analyses of social security schemes designed for income compensation, social services organization and labour market measures. Also development of system of social welfare in Lithuania is included in the study programme, and comparison of Lithuanian social policy system in general, and separate areas (social support, pensions, family policy, social services etc.) with other countries.

The need and relevance of the subject

Demographic and technological changes, climate change, inconsistency in economic and social development constantly increase the probability of the emergence of various social problems and increase the importance of ensuring harmonious social development, therefore in the countries of the world, and especially in the EU countries, more and more attention is paid to the formation of social policy and the implementation of its measures. Globalization of economic and social processes, internal and international migration of the population, changes in lifestyle and family patterns, human rights social movements, development of information technologies, etc. raises new requirements for social policy, which plays an increasingly important role in the strategy of ensuring the harmonious development of society. On the one hand, social policy is increasingly moving from the national level to the local level and requires effective solutions not only at the level of self-government (municipalities), but also at the level of communities and companies. By the other hand, globalization and Europeanization of social policy is on the nowadays agenda. "Welfare trap", long-term unemployment trends and the discrepancy between the supply and demand of labor resources show that it is necessary to promote the activation of social policy, actively develop social dialogue and NGO involvement. 21st century social policy has crossed its traditional boundaries and is less and less identified with social protection, but it actively influences the processes of education, training and vocational training, economic and financial policy, environmental protection and practically all areas of life. On the other hand, the expansion of the EU raises new questions about the international dimension of social policy.

The aim of the study subject is to analyse, compare and critically evaluate local, national and international social problems and the social policy used to solve them, to know various areas of social policy, principles and measures and the possibilities of their implementation in order to achieve the high level of welfare of the population and the harmonious development of society.

Study course content, topics and study methods

Study methods: reading of the scientific publications, research studies, comparative analyses by inviting information from the statistical sources (Eurostat etc.), critical evaluation, scientific writing.

- 1 topic. The main features of social policy in contemporary society. Development of social policy in Lithuania.
- 2 topic. Social justice and the role of the state in welfare development. Various concepts of social justice and their impact on social policy formation.
- 3 topic. Welfare state. Concept, models and historical development of welfare state. Transformation of welfare state and social welfare. Nowadays challenges for welfare state (by inviting particular examples and statistical indicators).
- 4 topic. Social risks and social problems in modern society (poverty, unemployment, disability, homeless, social exclusion etc.), and social security system addressing the social risks (EU and Lithuanian context).
- 5 topic. Social security benefits: structure, level of expenditure, financing by benefits, by functions; trends of financing in EU, LT.
- 6 topic. Aging of population in EU and LT, and social security in old age. Main social and economic challenges, and adequacy of social policy measures. Long term care policy: definition, trends and projections. The place of informal care in long term care and social policy developments.
- 7 topic. Unemployment, its causes and consequences for people and society: the concept of unemployment, indicators characterizing unemployment, their dynamics in the EU and Lithuania, prevalence in different population groups, consequences of unemployment at the micro and macro level. 8 topic. Employment and labor market policy, social protection in case of unemployment: the concept of employment and labor market policy and the main models, measures and implementing institutions, EU employment strategy and its implementation principles, legal regulatory mechanisms of employment and

Topic 10. Indicators of fertility change and procreative behavior, research sources, demographic
- statistical research methods. Innovative methods of studying the variation of the birth calendar and its

Short course annotation in Lithuanian (up to 500 characters)

Dalyko studijomis siekiama apžvelgti pagrindines koncepcijas, vyraujančias tiriant visuomenių socialinio struktūrinimosi, jų diferenciacijos bei socialinės integracijos procesus, socialinės sanglaudos tapsmą. Kurso metu siekiama pažinti integracijos socialines pasekmes ir numatyti Lietuvos galimus socialinius pokyčius bei jų tyrimus. Tam būtina pagrįsti įvairių socialinių procesų (socialinės stratifikacijos, socialinės atskirties, laisvo darbuotojų judėjimo, intelektinio kapitalo kaitos procesų) reikšmingumą, atskleisti jų tendencijas.

Short course annotation in English (up to 500 characters)

The aim of the course is to provide students with a modern overview of the basic concepts of social structure, the processes of social differentiation and social integration, and social cohesion. The course also aims to provide students with a thorough knowledge of the consequences of social integration and social change with an emphasis on these processes in Lithuania and their research. The students will be able to assess the significance of various social processes (social stratification, social exclusion, social movement, intellectual capital change) and disclose their patterns and trends.

The relevance of the course

The most important categories of social stratification and mobility, methodological problems of sociological research are analysed. The course also focuses on the analysis of empirical research data on issues relating to social stratification of societies. Upon completing this course doctoral students will be able to:

• Professionally investigate and analyse the trends of social stratification and social structuring; Demonstrate a systematic theoretical understanding of stratification processes and excellent empirical data research skills related to studying the social structures of society; Critically analyse, evaluate and systematically map the developments of the stratification and social mobility processes as well as analyse the links of such developments to public policy issues and practices; To communicate and professionally present ideas and research on social structuring and the ability to promote the dissemination of professional knowledge on social structuring processes, public policy and social modernization.

Course aim

To provide with deep and comprehensive knowledge social stratification and mobility; to develop ability to apply theoretical approaches for analysis of social stratification and mobility in society.

- 4. The forms and functions of social inequality. The relationship between classical stratification theories and social reality in empirical research. The relationship between new and classical forms of inequality in the context of social stratification theories. Social exclusion in Europe. The problem of measuring and indexing social exclusion and international comparison. The role of the state in fighting social exclusion. The issue of poverty.
- 5. Social class theories. Middle class concept in the social stratification theories.
- 6. Citizenship and social structure. Citizenship and social class. New social inequality and the principle of non-discrimination. Concept of citizenship in sociology. Citizenship as social status (T.H.Marshall); Citizenship as social role (R.Dahrendorf); Citizenship as a process (B.Turner, M.Mullard); Post-national citizenship (G.Delanty).
- 7. The concept and main theories of social integration. European social integration: main issues and policy fields.

The strengths and weaknesses of European social integration. Social integration research. The implementation of social rights in Europe. Main issues in socials rights implementation and social rights policy changes in Europe. The main obstacles impeding the implementation of social rights. The best practices in the implementation of social rights.

Theories of regional development

Short course annotation in Lithuanian (up to 500 characters)

Kurse pristatomas dalyko objektas, regioninės plėtros tyrimų raida, svarbiausios industrinio ir post-industrinio laikotarpio regioninės plėtros teorijos. Tradicinės industrinio periodo regioninės plėtros teorijos (Išdėstymo, centro- periferijos, aglomeracijų ir. kt.) ir jų šiandieninis taikymas. Post-industrinio periodo teorijos: Modernių regioninės plėtros teorijų svarbiausi akcentai; Industrinio rajono; Inovacinės aplinkos teorijos; Teritorinio kapitalo; Žinių "nuotėkių", Vystymosi trajektorijos priklausomybės (Path dependancy) teorijos; Regioninių inovacinių sistemų; Trilypės spiralės (Triple helix) koncepcijos; Naujoji ekonominė geografija; Miestų regionų teorija; Regionų valdymo teorija. Kurso pabaigoje aptariamos Lietuvos regionų plėtros tendencijos siejant jas su anksčiau pristatytomis teorijomis

Short course annotation in English (up to 500 characters)

The object of the discipline, the evolution of the research of regional development, main theories of industrial and post-industrial period are presented during the course. Traditional regional development theories of industrial period and their contemporary application (Alonso, von Thunen, Weber, Marshal, Central place theory, Rostov, Inn, Centre-periphery, etc.). Theories of post-industrial period: Main aspects of modern theories of regional development; Industrial district, innovative milieu theories; Territorial capital, knowledge "Spillover", Path dependency theories; Regional innovation systems, Triple helix concepts; The new economic geography; Theory of city-region; Theory of regional governance. The discipline is summarised discussing the main trends of regional development of Lithuania relating them to theories discussed before.

The need and relevance of the subject

Regioninės plėtros teorijų dalykas leidžia susipažinti su teorijomis aiškinančiomis regionų raidos ir vystymo ypatumus. Tokios žinios yra būtinos doktorantams, analizuojantiems įvairius regioninės raidos aspektus.

Course aim

Dalyku siekiama supažindinti studentus su egzistuojančiomis teorijomis, kurios įvairiais aspektais aiškina regionų vystymosi ir šalių regioninės raidos ypatumus. Siekiama, kad trečios pakopos studentai gebėtų atlikti savarankiškus, motyvuotus ir kokybiškus regioninius tyrimus įvairiose regioninės geografijos srityse.

- 1. Paradigm shift in regional development theories. This topic discusses the evolution of theories of regional development, presents the prevailing paradigms and research approaches.
- 2. Theories of regional development of the industrial period and their today's application. This topic analyzes the theories developed during the industrial period and applied in practice.
- 3. The locational theories. This topic discusses the general principles of locational theory, which explains how economic activities are distributed across of absolute space. Their evolution and the possibilities of today's application is discussed.
- 4. The theory of the location of the industry. This topic presents the works of M. Weber, Isard, Moses, devoted to the interpretation of distribution of industrial production and the arrangement of industrial facilities.
- 5. Theories of land use location. The works of Von Thunen and W. Alonso, presented in this theme, are designed to shed light on the differences in land use across the rural and urban space.

- 6. Industrial agglomerations. This topic discusses the works of A. Marshal explaining the formation of production agglomerations and their influence on industrial growth.
- 7. The theory of "spatial competition". The theme presents the works of H. Hotteling explaining the peculiarities of the concentration of the service sector in the territory.
- 8. The theory of central places. This topic presents the main works of W. Christaler and A. Losh, explaining the principles of urban network distribution and the peculiarities of the formation of an economic landscape.
- 9. Regional theories of development and evolution. The theme presents the theories of W. Rostov, Inn, Metropolitan Hinterland, Centro-periphery.
- 10. Features of the theories of the post-industrial period. The topic examines the most important general features and features of theories explaining the peculiarities of regional development in the post-industrial period.
- 11. Theories of clusters and industrial districts. The most important theories emphasizing the importance of spatial concentration in the development of production, the concept of the Neo-Marshal model, are presented.
- 12. Innovation theories. This topic analyzes the concepts of theories that emphasize the importance of learning, innovation (Innovative milieu), learning region (Learning region), Regional innovation systems, etc.
- 13. The concept of territorial capital. The theory of R. Camagni is presented, emphasizing the importance of endogenous resources in the development process.
- 14. Theories of knowledge and entrepreneurship. This topic explores theories that emphasize the dependencies of knowledge creation and exchange, and entrepreneurship. Knowledge spilower, Triple Helix and other similar concepts are introduced.
- 15. Theories of historical inertia. This topic presents theories that emphasize the importance of historical inertia of development (Path dependency").
- 16. New economic geography. The works of P. Krugman and subsequent authors are presented, emphasizing the importance of spatial economic analysis and the concentration of geographical factors in the processes of production.
- 17. The theory of urban regions. The theme explores theories explaining the evolution of cities into urban regions, their structural changes and the growth of significance in the global economy.
- 18. The theory of regional management. Theories explaining the peculiarities of territory management and its significance for the successful development of the economy (Theories of growth coalitions Regimes theories) are presented.
- 19. Peculiarities and trends in the development of Lithuanian regions. The theme presents the main features of Lithuania's regional development (spatially specifics of economic development, development of urban regions, transformation of the settlement system, etc.), linking them with previously analyzed theories.

The course is based on self-studies of references sources and preparation of written project work on the topic agreed with the course teacher.

Short course annotation in Lithuanian (up to 500 characters)

Šiame kurse nagrinėjamos socialinių sąjūdžių ir kolektyvinių veiksmų teorijos, analizuojant šiuolaikinių socialinių sąjūdžių atvejus. Short course annotation in English (up to 500 characters)

This course focuses on theories of social movements and collective action through an examination of contemporary movements. The course aims to further understanding of social movements by examining how they develop, are sustained, and decline. The course begins by examining theories of social movements and the ways in which understanding of social movements has changed over time.

The need and relevance of the subject

The study of social movements, collective actions and contentious politics are more relevant than ever. Social movements and protests have in recent decades mobilized in relation to issuess of, gender and sexuality, the economic and social policines, climate change. Social movements and collective actions may transform social norms and values, construct collective identities, change law and impede interests groups that ignore common good.

Course aim

To able to analyse and evaluate the role of social movements in contemporary societies, to know the impact of social divisions and institutional alterations that give rise to current movements and protests actions, to be conversant to repertoires and strategies of social movements and protest actions and reasons of their success or failure..

Study course content, topics and study methods

- 1. The concept of social movement. Classical and new social movements.
- 2. Research methods of social movements and collective actions.
- 3. The theories of deprivation and their adaptation to social movements and protest action research.
- 4. Resource mobilization and political process theories mobilizacijos ir politinio proceso
- 5. Framing and cultural theories of social movements and contentious politics;
- 6. The role of social media for protest mobilization.
- 7. Participation in collective actions
- 8. New social movements: collective identity and emotions
- 9. Coalitions and transnational social movements
- 10. Cycles of a protest. Strategy and development of protest actions
- 11. The success or failure of social movements
- 12. Activism in social movement research.

Evaluation criteria of study achievements

The final grade consists of 1) individual paper (40 % of the final grade): critical and focused review of literature related to the doctoral thesis topic and prepared on the most recent studies (40 000 words and symbols); 2) oral presentation (30 %); 3) exam (30 %).

Didelis dėmesys skiriamas gerovės valstybės raidai Skandinavijos ir Baltijos šalyse. Pristatomi socialinės politikos pokyčiai Vidurio ir Rytų Europoje ir Azijos šalyse. Aptariamos tokios koncepcijos kaip "socialinis investavimas", "produktyvi gerovės valstybė", "inovacijos" socialinės politikos srityje; analizuojamas klimato kaitos poveikis socialinei politikai, Covid pandemijos iššūkiai bei su gyventojų senėjimu susijusios problemos.

Short course annotation in English (up to 500 characters)

The course presents the main theoretical approaches explaining the development of the welfare state, the typology of the welfare state, and the problems of the modern development of the welfare state. The aim is to reveal the latest changes in the field of the welfare state and the reasons for those changes. The course analyzes the impact of globalization, European integration, migration, family deinstitutionalization on the welfare state. Great attention is paid to the development of the welfare state in the Scandinavian and Baltic countries. Changes in social policy in Central and Eastern Europe, Asian countries are presented. Concepts such as "social investment", "productive welfare state", "innovation" in the field of social policy are discussed; the impact of climate change on social policy, the challenges of the Covid pandemic, and problems related to the aging of the population are analyzed.

The need and relevance of the subject

The subject is relevant for doctoral students who are interested in comparative studies of social policy and the welfare state.

Course aim

The course aims to reveal and explain the latest developments in the field of the welfare state in Europe and the world.

- 1. Introduction. The purpose of the subject is explained to the course participants, the main topics are presented, and the workload is introduced.
- 2. Development of the welfare state in Europe: past, present and future. This topic analyzes the historical, economic, and political reasons for the emergence of the welfare state. Theoretical assumptions and models of the welfare state explaining the development of the new and old welfare state are discussed. Readers are introduced to the main and latest theories explaining the development of the welfare state and the latest typologies of the welfare state.
- 3. Scandinavian welfare state model. The topic answers the questions: what is special about the Scandinavian model? Why can not it be transferred to other countries? Is it sustainable in the era of

globalization and Europeanization?

- 4. Development of the welfare state in Central and Eastern Europe. The challenges experienced by the social policy systems of Central and Eastern European countries are analysed, and the aim is to reveal the causes of those challenges.
- 5. Migration and social policy. Readers are introduced to the impact of migration on the development of social policy in developed and developing countries. Concepts analyzed: social dumping, social tourism, free labor movement.
- 6. Social investment and a productive welfare state. The topic raises the following questions: What kind of welfare state do we need today? How can new technologies, investment in education, lifelong learning contribute to the development of the welfare state? Productive welfare state or protectionist?
- 7. Family policy in different welfare state models. Such social policy challenges as the aging of the population, the increase in pension and health care costs, the deinstitutionalization of the family, and individualization are analyzed.
- 8. Development and perspectives of the Baltic welfare state. The topic analyzes: What is special about the Baltic countries? In what direction their welfare state systems developing? Can "old" and "new" welfare state theories and typologies explain the changes in the Baltic countries?
- 9. Social policy in Asian countries. The topic introduces and analyzes the features and challenges of social policy in Asian countries.
- 10. Housing policy an integral part of the welfare state. The topic analyzes the place of housing policy in the system of the welfare state, its importance for the well-being of the population and life satisfaction.
- 11. Climate change and social policy. The topic analyzes the following questions: Is climate change a real threat to the stability of social policy? What are its consequences?
- 12. The Covid pandemic and social policy. The topic analyzes the impact of the Covid pandemic on the development of social policy in the CEE countries.

Evaluation criteria of study achievements

Written paper/essay 50%. Exam 50%.
